## **PLEASE READ** before completing this form:

- 1. All fields <u>MUST</u> be complete in order for us to process your I-20. If a question does not apply to you, please write N/A in the appropriate field.
- Please attach financial documents even if you have sent them during your application.
   Bank statements, checking and savings accounts are acceptable. Your I-20 request form is not complete without the financial documents.
- 3. Send the form to the admissions office (if you are a Graduate student) or directly to the ISS Office (if an Undergraduate student) after completion.
- 4. If you have only ONE given name, enter it as your Last Name and enter "FNU" (<u>First Name Unknown</u>) in the First Name field. Please note that some U.S. government officials are not familiar with the FNU acronym and will assume that your first name is FNU. As such, you will need to explain that you only have one name and FNU stands for "First Name Unknown."
- 5. Attach a copy of the biographical page of you passport and those of any dependents who will be accompanying you. The name/s you enter on this form should match the name/s on your passport.
- 6. If you are a transfer student, please attach **Transfer Clearance Form**.
